**Sub: Charges for re-inspection, call cancellation, revalidation of IC etc.**

To bring out the uniformity in cancellation, rejection & re-inspection, revalidation charges etc. the instructions have been issued and circulated from this Office vide letter of even no. dated 16.10.2017, under ref (iii) above.


Consequent upon finalization of TPI tender floated by W. Rly, Railway Board has issued a letter Vide No. 2022/RS(G)779/9 dated 01.12.2022, under ref. (ii) above, wherein the charges against call cancellation, Revalidation of IC, Re-inspection and inspection acceptance involving stage inspection has been revised.

In view of above, charges for cancellation, rejection, re-inspection and revalidation have been reviewed. Henceforth the following rates of charges shall be applicable against purchase orders issued by Indian Railways and non-Railway clients, against the activities mentioned:

**Note:**

- For non-railway Orders/Contracts covered under MOU/Contract/agreement with client shall be exempted from above instruction and such cases shall be dealt as per MOU/contracts/agreements/agreed rate.
- The rates mentioned above shall be a part of all Offers submitted to Clients particularly for non-Railways. However, in cases of tenders and clients' requirements, RIO Head shall take the final decision on the above-mentioned charges on case to case basis.
